Lecture 1: Immigration, Labor Markets and the Skills and Tasks Framework

The aim of this class is to understand the consequences of immigrants on the labor market and productivity of the host country. Immigrants can act as substitute or complement to natives, which may affect labor supply and wages in different ways. In addition, by bringing new or complementary skills to the host labor market, immigrants may influence the choice of natives' productive tasks. We will investigate these questions both theoretically and empirically, paying particular attention to the framework used, which is common to several other areas of labor analysis.
